These minutes reflect the order in which items appeared on the meeting agenda and do not necessarily reflect the order in which items were considered.

REGULAR AGENDA

President Ashcraft called to order the regular session of the Rancho Santa Fe Fire Protection District Board of Directors at 1:00 pm.

Pledge of Allegiance

Director Malin led the assembly in the Pledge of Allegiance.

1. Roll Call

Directors Present: Ashcraft, Hillgren, Malin, Tanner. *Director Hillgren participated via teleconference*

Directors Absent: Stine

Staff Present: Fred Cox, Fire Chief; Dave McQuead, Deputy Chief; Marlene Donner, Fire Marshal; Kim DeAvila, Administrative/HR Manager; and Karlana Rannals, Board Clerk.

2. Special Presentation

- a. Chief McQuead summarized a call that Colton Israels, Fire Services Assistant, was near a swift water rescue in February 2019. A victim was holding onto a tree after their car was swept down Escondido Creek in significant flooding. His quick action called dispatch requesting an emergency response and assisted on-duty personnel in locating where the person was clinging to a tree. He was presented a plaque in appreciation for quick actions.

7. Public Hearing

- a. *Fire Mitigation Fee Program: Resolutions Adopting Multi-Year Facilities and Equipment Plan for Rancho Santa Fe Fire Protection District*

President Ashcraft opened and closed the public hearing. Ms. Rannals informed the Board that she had not received any comments regarding the fire mitigation fee program.

8. New Business

- a. *Successor Memorandum of Understanding with Rancho Santa Fe Miscellaneous Employees*

Chief Cox informed the board that the District is in receipt of a letter from the respective bargaining unit cited requesting to meet and confer for a successor MOU, which expires December 31, 2019. He requested that an ad hoc committee be created to negotiate a successor contract.

MOTION BY DIRECTOR MALIN, SECOND BY DIRECTOR TANNER, and CARRIED 4 AYES; 0 NOES; 1 ABSENT; 0 ABSTAIN to appoint Directors' Ashcraft and Malin as the agency negotiator for a successor MOU.

- b. *Preliminary Budget FY20*

Karlana Rannals gave a PowerPoint presentation on the Preliminary Budget for FY20. She reports that preliminary revenue projection \$18,050 (in thousands) increased (3.4%). The revenue anticipated is primarily

from the San Diego County Tax Assessor's FY20 estimated receivables (\$14,420); the remainder is comprised of CSA-107 tax shortfall, developer reimbursement, FEMA/OES reimbursement, fees, and lease revenue.

She reports that the overall Operating Budget of \$13,733 (in thousands) increased (.1%). She summarized the expenditure changes between the proposed budget and FY20 estimated expenditures that include:

- Personnel Cost – 13,733 (3.2%) – the overall decrease increase is the direct result that at this time of additional payments to CalPERS to reduce the unfunded accrued liability and a full year's expense for SAFER grant personnel. In addition, the preliminary budget does not include any salary adjustments.
- Contractual Services (+14.8%) - the overall increase are the results of the increases to
 - Commercial Insurance
 - Other Contractual and Professional Services
 - Utility costs
 - Training
 - Vehicle maintenance and repairs
- Material & Supplies (+93.7%) – the overall increase are the results of the increases to
 - Fuel
 - Medical Supplies, which includes the purchase of Defibrillator's in excess of \$500k
 - Safety Equipment

She also provided an overview of the District's cash position and she responded to questions from the Board.

Chief Cox reported that the resolution presented is a part of the summary report prepared each year for the County of San Diego for the Fire Mitigation Fee program. As previously reported, he has requested additional funding for the construction of RSF5 due to the increased costs.

Ms. DeAvila summarized the staff report and reported that the resolution presented is to allow for non-safety employees of the District to contribute thru a payroll tax into State Disability Insurance Program. She also noted that elected officials and retired annuitants would be exempt from this program. This is no cost to the employer. Staff responded to questions from the board.

10. Oral Report

a. *Fire Chief*

1. District Activities

- RSF5 Construction Update and Groundbreaking: he distributed photos of the progress of the construction and that the plans are complete and the pad certified. He is still waiting for the building permit.
- Waiver of District Fee: He reported that he waived a \$500 administrative fee on a forced abatement. The property owner had passed away and staff was working with a family member who did not receive the notices in time.

- Fuel Mitigation Projects:
 - Escondido Creek will be limited to roadway clearance this year. This abatement does not require CEQA approval
 - San Dieguito Creek desires to clean the creek bottom up to the Crosby development. They plan to begin the work in November.
 - SDG&E is working on abating beneath and near the power lines
- Other Activities:
 - He has been appointed to the LAFCO Advisory Committee
 - The Chinese Bible Church project in the 4S Ranch area will be discussed at the Board of Supervisors meeting on July 25. He plans to attend as he has concerns regarding the flow of traffic and requiring necessary traffic lights in front of RSF2.
 - He plans to send a letter to Supervisor Desmond about the death of the Eucalyptus trees, and seeking financial support for their removal. There is also a problem with many homeowners having their insurance cancelled.
 - Bill Smith has prepared a site plan for the RSF tenant improvements. This plan will be taken to the County for their comments.
 - He is meeting with RSF School on June 20 to discuss the use of their parking across the street from RSF1.

b. *Operations – Deputy Chief*

Chief McQuead reported that Captain Danner was deployed to the fire in Inyo County. There was a 2.5-acre brushfire in the Fairbanks Ranch area. He also attended the meeting in Elfin Forest about evacuation of large animals.

c. *Volunteer – Volunteer Recruitment & Retention Coordinator*

Not in attendance – no report.

d. *Training – Battalion Chief*

Deputy Chief McQuead reported that safety personnel participated at fire school held at Camp Pendleton. In addition, personnel are performing pre-fire planning at the Ewing Preserve, and in the Mt. Israel area.

e. *Fire Prevention – Fire Marshal*

FM Donner reviewed the previous month's statistics noting 412,000 square feet of new construction, and that there are several projects that are moving forward, including a proposed residential care facility.

f. *Administrative/Human Resource Manager*

Ms. DeAvila reported on the following:

2. A conditional job offer has been made for the recent vacancy

5. She will be attending the Society of Human Resource Managers (SHRM) Conference in Las Vegas June 24-27, 2019

Expected Large Fire Potential



SUMMARY:

- Temperatures slightly above normal, mainly across inland areas.
- Below normal number of summer thunderstorms outside the deserts.
- Large fire potential trending above normal this summer in the foothills and inland valleys due to tree mortality.
- Above normal large fire potential spreading into Southern California this fall due to heavy fine fuel loading.

WEATHER DISCUSSION:

The past month was cooler and wetter than normal for the southern section of the district as onshore flow continued to dominate the weather pattern. Several unseasonably deep troughs produced some spotty showers and wet thunderstorms, bringing measurable precipitation to the Sierras as well as other mountainous areas. Southern California also experienced some light rain which is quite unusual for June. Due to the pervasive stratus coverage, Southern California temperatures responded accordingly with monthly departure from average readings anywhere from 4-6 degrees below average.

However, areas of Central and Northern California west of the Sierras experienced wildly different weather conditions during the past 30 days. Northerly winds kept marine layer coverage at bay along the central coast while some downsloping effects allowed the San Joaquin Valley to see frequent 100-degree temperatures. Monthly temperature averages for June were substantially above normal from areas extending north of Santa Barbara and Kern County (**Figure 1, next page**).

MONTHLY/SEASONAL OUTLOOK – OSCC, RIVERSIDE



Cooler than average sea surface temperatures may have been partially responsible for frequent troughs off the coast as well as stronger than normal jet energy across the Pacific. There are signs this trough-heavy pattern may change to more of a blocking pattern if the Pacific North American Pattern (PNA) index goes to a positive value as forecast by the models used by the Climate Prediction Center. This along with a weakening jet may keep a strong ridge aligned over the Eastern Pacific.

The result of ridging off the coast would be a change to a warmer and drier weather pattern for the Southern CA with far less marine layer coverage. Central CA may see the heat of late June continue into July.





Figure 3: NMME Precipitation Anomalies, Aug. - Oct.

In fact, much of the continental U.S. is forecast to see above normal temperatures this summer. Between the expected above normal temperatures of the Eastern and Western U.S., a patch of near normal temperatures is forecast this summer into fall over the Midwest (**Fig. 2, right**). This might be where the main axis of monsoonal moisture may lie much of the summer...far east of the Geographic Area. Given long range models consistency with regard to precipitation distribution over the CONUS, we are expecting below normal summertime monsoon-generated thunderstorm activity this year (**Fig. 3, bottom**).

A lack of moisture over northern Mexico so far this summer may also lead to a summer monsoon which is delayed. Areas of the far eastern desert may see closer to normal precipitation amounts this year, but most forested areas - including the Sierras - should have fewer than normal storms this summer.

Figure 2: NMME Temperature Outlook, Aug. - Oct.



Figure 4: Tree Mortality, Sierras




FUELS AND DROUGHT OUTLOOK

Much of this calendar year, conditions have remained rather cool and wet which has led to a slow start to fire activity both locally and nationally. But from a fuels perspective, conditions are still favorable for a busy summer fire season once again. Tree mortality and its subsequent influence on fuels in the Sierra Foothills will continue to be the principal area susceptible to large fires (**Fig. 4, left**). The tall and dense grass crop generated by the wet winter may lead to new starts propagating rapidly from the ground fuels into the taller ladder fuels. These large diameter, heavy fuels are co-mingled with a high amount of dead fuels, especially from Tuolumne County southward. Should a new fire develop in these areas during hot or windy periods, containment may prove challenging.

An expected lack of summer thunderstorms in the Sierras may lessen the chance of a lightning-started fire, but fires that are human caused (the majority of fires across the Geographic Area) may find trees, shrubs and grass with below normal fuel moisture in both live and dead fuels. Sunnier and hotter weather may result in fewer starts, but the fires that do develop have a greater chance of becoming large in a low-monsoon scenario.

The rest of the Geographic Area should see large fire potential increase to above normal from north to south as the summer progresses into fall. Live fuel moisture in chaparral and other native shrubs of Southern California may remain near to slightly above normal through the summer, but by fall, these fuels should be dry enough to support large fire growth. Like fuels further north, there are widespread dead fuels present due to the long-term effects caused by the 5-year drought. These fuels will likely be the driver of large fire activity in the summer and early fall months. By the middle of fall, large fire activity may spike across Southern California once offshore wind events become increasingly likely.

Large fires will likely be driven by fuels due to the poor vegetative health of many fuel beds. Once the dead fuels assume a below normal level of fuel moisture (possibly as soon as late July), there will be an above normal chance of seeing large fires. This increased large fire threat will likely not be alleviated until meaningful rainfall returns in November or December.

SUBJECT: ADMINISTRATIVE CITATION PROCESS
DATE: JULY 10, 2019



BACKGROUND:

Staff wishes to discuss the option of establishing an Administrative Citation process as a means of enforcement when other remedies available to the District are unsuccessful in gaining compliance to a Fire District Ordinance or Code. The analysis below is a brief overview of the Administrative Citation process. At this point, staff is only seeking direction to proceed or not to proceed in the formulation of such a process.

ANALYSIS / DISCUSSION:

Administrative citations are authorized under Government Code Sections 53069.4 and Health and Safety Code Sections 13861(h) and (i), 13870 and 13871. Administrative citations can be an effective way for the District to achieve cooperation and encourage violators to more quickly come into compliance. An administrative citation is a civil citation and is not punishable by jail and does not appear on a criminal record.

Administrative citations may be used in lieu of, or in addition to all other legal remedies, criminal or civil, which the District may pursue to address continuing code violations that have not been mitigated by a property owner. The issuance of citations would generally be reserved for those cases of non-compliance when all reasonable accommodations have been made by the District and timeframes have been given following a notice of violation.

Administrative citation fine amounts are set forth in the Government Code and would be adopted by Ordinance in the District's Fee Schedule. The issuance of 2nd and 3rd occurrence citations would only apply in instances of continued non-compliance. The maximum fine for violations of local building and safety codes is punishable by the following:

1. A fine not exceeding one hundred thirty dollars (\$130) for a first violation.
2. A fine not exceeding seven hundred dollars (\$700) for a second violation of the same ordinance within one year of the first violation.
3.
 - A. A fine not exceeding one thousand three hundred dollars (\$1,300) for each additional violation of the same ordinance within one year of the first violation.
 - B. A fine not exceeding two thousand five hundred dollars (\$2,500) for each additional violation of the same ordinance within two years of the first violation if the property is a commercial property that has an existing building at the time of the violation and the violation is due to failure by the owner to remove visible refuse or failure to prohibit unauthorized use of the property.

Additional amounts such as administrative costs, fully burdened hourly rate of staff, interest, late payment charges, cost of compliance re-inspections, attorney fees and collection costs may be in addition to the fine. A notable exception to the tiered fine schedule referenced above would be in the case of a fireworks violation, which would be subject to a fine of \$1,000 per occurrence for each offense, and could be applied cumulatively.

A third party citation processing agency would be used to bill and collect fines.

Among other provisions, the ordinance may allow for dismissal of a citation if:

1. The Fire Marshal determines that there was no violation as charged, or if such dismissal is in the interest of justice;
2. Suspension of fine imposition in instances where a violator has filed for permits necessary to achieve compliance and such permits are pending government agency approval;
3. A hearing request process to contest a citation.

A person who receives an Administrative Citation may contest the citation on the basis that there was no violation of the code, or that he or she is not the responsible person. To contest the citation, the person shall submit a request for a hearing to the District's Board Clerk within 30 days following the date of the Administrative Citation.

The Fire Chief of the District shall designate the Hearing Officer for the Administrative Citation hearing. The Hearing Officer shall be an impartial person, including, but not limited to:

1. A Fire Department employee from a neighboring agency, or
2. A person that the District utilizes for impartial Hearing Officer Services.
3. A person selected randomly from a panel of local attorneys who have been admitted to practice before the courts of this state for at least 5 years willing to volunteer as a Hearing Officer.

Should the person seeking the hearing reject the Hearing Officer selected by the District, then the Hearing Officer shall be hired from an organization which provides such Hearing Officer services and the cost, therefore, shall be shared equally by the District and the person.

No hearing shall be held unless the fine has been deposited in advance or an advance deposit hardship waiver has been issued. At the hearing, the party contesting the citation shall be given the opportunity to testify and to present evidence concerning the citation.

After considering the testimony and evidence presented at the hearing, the hearing officer shall issue a written decision to uphold, dismiss or modify the administrative citation. The hearing officer shall state the reasons for the decision and shall send a copy of the decision to the person requesting the hearing and to the enforcement officer. The decision of the hearing officer is final, and may not be appealed.

A person aggrieved by the Hearing Officer's decision on an Administrative Citation may obtain review of the decision by filing a petition for review with the Superior Court in San Diego County within 20 days after service of the final decision in accordance with the timelines and provisions set for in California Government Code Section 53069.4.
